INCIDENTS FROM INDIAN SOCIETY

Current Situation in India

There has been a rampant increase in the number of rape case throughout India. Eve teasing and molestation have become common occurrence. Rape cases increase by 873% from 1971 when the oldest case of rape was first recorded by NCRB. (Flugel J.e., 1930)

- ➤ We have such an ugly statistic in spite of fact that the most of the cases of rape go unnoticed due to the social stigma attached to it. (Pandey, Oct 2010)
- ➤ The increasing rape statistics has also raised a topic for debate. Are women to be blamed for wearing provocative clothes?
- ➤ 2007 incident when a girl was openly raped on New Year's Eve near the Gateway of India. (Pratibha, 2007)
- Recent incident in Guwahati where a girl was publicly molested in busy place in the city by a mb of around 30 people at around 9:30 pm. The mob of people continued this act for about 30 minutes. (Mahila Kalyan evam Sashaktikaran, 2013)
- ➤ In both the above instances and many more which go unreported we may witness that the girl who are publicly harassed are usually dressed up in short clothes and what is termed as provocative. In the light of recent events and the increasing number of such cases, it is pertinent to discuss whether the dressing sense of a woman makes her more vulnerable towards these crimes.

WHAT ARE PROVOCATIVE CLOTHES

- Moreover, there are no definite parameters as to what is 'provocative' and what is 'appropriate' they still continue to generic terms. However, different groups and communities have given different definition of what is 'appropriate' and what is not.
- ➤ In Mizoram Schools in 2010 short skirts (ones that don't start at navel and end below the knee) were banned to promote decency and discipline by the government
- ➤ Kashmir by Jamiat-e-Islami (2012) liberty and freedom Aimed mainly at tourist, the party intended that "some

- tourists, mostly foreigners, are seen in mini skirts and other objectionable dresses that are against our ethos and culture, and unaccepatable to civil society. Kashimiris cannot, for the sake of their economy, give up their divine sic values at any cost." Fortunately, the tourism department ingnored the groups please.
- The issue is not only restricted to skirts and revealing clothing but even jeans and t-shirts have been considered provocative.
- ➤ In 2011, a khap panchayat in UP's Shoram village blamed 'jeans' for provoking eve teasing and encouraging young couples to elope.
- ➤ In 2012, Women and Child Department (WCD), Haryana branded jeans and T-shirts as 'indecent'. The circular sent out to employees asked women to wear a sari or a salwar Kaameez and stay indecent western dress.
- ➤ It may be concluded here that not only revealing clothes but all western clothing has come into dispute.

SOME STATEMENT OF RESPONSIBLE

- ➤ In the words of Karnataka's women & child welfare minister C.C. Patil "women shold know how much skin they should cover". He stated that incidents like rape and sexual harassment can be attributed to the decline in moral values in men indirectly caused by women dressing "provocatively."
- ➤ Dinesh Reddy, The DGP of Andhra Pradesh made a statement which was widely televised statement were he balamed the rise in rape cases on women wearing 'fashionable' clothes. He said the police could be nothing to deter rapists, as long as women 'provoked' men by wearing 'fashionable' clothing

- ➤ "Eve teasing is very old concept. The reason behind its increase is short dresses worn by women. This in turn instigates men." Was what the Trinamool Congress MP, Chiranjit Chakrobaorty had to say.
- ➤ 'Ladkiyan Der Ratt akele Ghar Se Bhar Na Nikle 'Delhi' etc.
- ➤ Chief Minister Sheela Dixit
- Surprisingly all these and more comments came from the people who are responsible to protect and serve our nation. Instead of condemning those who commit such heinous offences people are raising fingers at the women who become the victim of such crimes.
