ON THE SITUATION IN EUROPE

ABSTRACT

The very difficult factually, and for analysis, modern political and psychological situation in Europe, causes us to see importance of our earlier works [1-7] that both give some coherent explanation to this situation and they obtain here additional justification. Definitely, the argument does not relate to everyone in the 1-billion population of Europe; for instance, we do not touch here the fascist elements with their traditional position toward foreigners. Such well known a "triviality" is just regretful.

Such well known a "triviality" is just regretful, even though it reflects some essence of the human nature – just as the tendency of Islam to expand reflects it.

THE LINE OF THOUGHT

I [1-7] a new line of thought regarding hooliganism is suggested and developed. In this original line, an intellectual overburden is suggested to be the cause for the cruelty. Thus explained, hooliganism in focus is seen as a specific one; -- the relevant hooligans are not really guilty in the cruelty developed in them.

It is supposed in [1-6] that the intellectual overburden leads to imbalance in the development of the different parts of the brain (for brevity, we shall speak only about brain hemispheres; this macroscopic view is not absolutely necessary, but accepted by many). This imbalance is felt by the human so strongly, that for stopping the relatively strong development of the right hemisphere, cruelty becomes helpful, and even necessary.

The real cause for the cruelty is thus a result of the narcissistic euphoria, associated with the unlimited belief of humans in their intellectual ability, which "invites" the intellectual overburden. This belief, developed on the long

way of the whole humanity, is natural, but became, we say, the greatest problem of the modern society.

This explanation of [1-6] of an extreme human behavior, was originally purposed to explain (see especially [1]) the Holocaust, but becomes relevant, as we argue, at the present situation in Europe, associated with the "flood", or "invasion", of the Muslims. The central question here is: "Why Europeans are so indifferent regarding the fact that Muslims are really capturing Europe, which will inevitably and drastically change it?" This unexpected and very strange acceptance by the Europeans of the situation can be explained only by the position of [1-6]. Thus, the present situation both constitutes an application and justifies the conclusions of [1-6].

That the Europeans are so weekly patriotic regarding their traditional culture, is because they are tired of this culture, and thus not aware of the Muslims to change it, -- which the Muslims, who are instructed by Quran the Islam to become dominant at every place they live – will willingly do.

There are two historically huge steps in the development of the Muslim World, of which only the first step is well understood, and the second step, occurring at present, is not understood.

The first step is that at its rise (that started from the early 7th century) Islam brought a relatively high culture to numerous large societies, which made this religion very popular and powerful. The second present, and in some sense opposite, step is that Islam starts stopping the too excessive human intellectual development, -- the development making Intellect the dictator of this world, -- which Muslims cannot tolerate, because they cannot let the Intellect and the

technological development to replace Mohammed. Muslims feel their strength and vocation to fight the novelties, and they wish to change this world to have a proper and firm position in it, which, as they are sure, they deserve.

Before making our specific point deeper, let us notice that the more standard data, -- represented here by [8-12], is of a purely description nature. One sees that the regretful (as a rule cruel) events, associated with the psychological unfitting of the Muslim's' inclusion to the basic European society, - are so "tempestuous" that the description aspect appears as natural, as it would be in a reportage on a sport competition. However, the statistical data of [12] is very valuable. According to it, from 2015 to 2030, the Muslim population, -- practically everywhere where it is present now in a significant amount, -- will be increased by some 30%, while the natural increase in the population of the developed Western countries is defined (in average) by some 1.5 child per woman. Consider that at present there already is almost 50.000.000 Muslims in Europe.

An exception presents the article [13] by the Professor at the University of Paris Guy Molière. This article has an analytical vision expressed in its conclusions, close to those to which we came in our own way, in view of our "old" analysis in [1-7]. However, though, contrary to the "reporters", Professor Millière is able to see the real meaning (the danger) of the psychological problems of Europe – also he does not explain the causes for these problems, as we do.

We realize that a reader can find our line of thought unexpected, but it inevitable leads to some understanding and seeing the coherence of the events. The "forgiving" of the Europeans the Muslims was absolutely not unexpected for us – it is directly explained by our general thesis that in the modern world, the "educated" people are tired of their culture. So, let us return to the original argumentation.

THE INTUTIVE ASPECT

Though being originated myself from Russia, and thus essentially belonging to the European Culture, -- I cannot surely say that Muslims are wrong. With my independent thinking due to my technical education and my descent from some important Rabbis, I believe in God's will and hand, and am also convinced that while looking back in time, we often start to see the meaning and importance of the past events differently. Only God, who sees the future, knows what is for good, and what is for bad. It is clear that both Muslims and the original Europeans approach the quickly changing situation purely *intuitively*. The Europeans will never confess that they are tiered of their culture, though it

becomes obvious that this culture, with its numerous mainly technical details, becomes very tedious for simple people.

The feeling of the Muslims that the Europeans will accept their ruling and culture people is also just intuitive, but clear and strong, and they seem to be quite confident regarding their victory.

Because of this situation, which certainly is very difficult for the societal academic knowledge, -- we believe that recalling the position of [1-7] is necessary and timely. Even if it lights up not all of the faces of this versatile situation, -- it enlightens the very important psychological face, making many things coherent.

There is no other explanation for the present historically unique physical and mental situation, but our supposition of the accumulation and bursting out a mental disease, associated with the intellectual overburden and the resulted unequal development of the relevant parts of the brain. In Europeans, the intuitive fear of their (too) highly developed complicated culture is the fear of this mental disease, and it becomes more and more clear that the frightened Europeans will accept the psychological simplification of their live, as it will be imposed by Islam.

Of course, the reference to the brain activity in [7] is somewhat problematic; -- we still cannot know why the unequal development of the relevant parts (hemispheres) of the brain is so intolerable for humans that it obtains the form of a mental disease. See [1-6] for different cases of the not really understood cruelty, including that expressed in the Holocaust. However, what is better – to wait, perhaps several hundred years, until molecular biology will "explain everything", taking the risk that the humanity will destroy itself much earlier, or be with the macroscopic sociological, though nonstandard, outlook of [1-6]?

We certainly are for the sociological approach, just noting that work [7] suggests some macroscopic system arguments helpful for understanding the relevant role of the hemispheres of the brain. These system-theory arguments do not belong to the molecular biology, and also have some macroscopic character, which was the purpose of [7].

An important point of the analysis of [1-6] is the position that human intellectual ability, and the principles of thinking and analyzing the information, are basically given to us once and forever, with the creation of a human. Not understanding this fact, led the humanity to a kind of euphoria re human intellectual ability. We — especially Europeans — were never sufficiently careful re the problem of

the intellectual overburden. The correct position would be, however, to control the intellectual (informational) feeding of our mind, just as we take care regarding the regular food. It is unfortunate that headache is not so easily developed as the pain in the stomach. Thus, we come to the dangerous intellectual overburden, and the very difficult political situation.

ON THE SELF-ACCELERATION OF THE CREATION OF POTENTIAL IMPERIA

There is one more cause – of a quite general nature - for the success of Muslims in the process of capturing the world. Again, the point is in the simplicity of their psychology and actions.

In order to control a huge territory and population — one has to use simple principles of ruling, which seem to be attractive for many, and this helps in enlarging of the imperia. On the other hand, this enlarging enhances the important of the simplicity of the ruling. Thus, the "positive feedback" — between the simplicity of the principles and the size of the imperia, almost automatically leads to the enlarging of the imperia. This observation further stresses importance in the simplicity in the ruling of people, and human psychology in general.

CONCLUSION

We have argued that it is not a guilt of anyone, but the natural psychological situation that the Muslims are strengthening in Europe, i.e., that the Europeans are withdrawing from their positions of owners. From the point of view of the strength, -- one finds here a compliment for Muslims who succeeded in preserving the simplicity of their societal principles, during so many centuries. There also is the evidence of the fact that democracy leads the society to a state of tiredness.

The capture of Europe by Muslims will not be dramatic. Simply many Europeans will willingly accept Islam as their religion. The cases of acceptance are, for instance, already observed in Germany, -- just against the ancient German proverb saying: "Und willst du nicht mein Bruder sein, so schlag ich dir den Schädel ein."
